

1. Power off your phone.


2. Refer to the following picture for SIM/SD card installation.

Specific Absorption Rate (SAR) information:

Body-worn Operation

This device was tested for typical body-wom operations. To comply with RF exposure requirements, a minimum separation distance of 1.0 cm must be maintained between the user's body and the handset, including the antenna. Third-party belt-clips, holsters, and similar accessories used by this device should not contain any metallic components. Body-wom accessories that do not meet these requirements may not comply with RF exposure requirements and should be avoided. Use only the supplied or an approved antenna.
